

Wanna Get Away Day Sweepstakes (“Sweepstakes”)

Official Rules

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID IN ALASKA, FLORIDA, NEW YORK, PUERTO RICO, RHODE ISLAND, AND WHERE PROHIBITED OR RESTRICTED BY LAW.

- 1. Eligibility:** Sweepstakes is open to all legal residents of the fifty (50) United States and the District of Columbia (excluding Alaska, Florida, New York, and Rhode Island) who are nineteen (19) years of age or older and have valid email and Rapid Rewards® accounts at the time of entry. It is free to enroll in Rapid Rewards (to enroll, visit www.southwest.com/enroll). Rapid Rewards accounts are subject to its Rules & Regulations. Employees of Southwest Airlines Co. (“Sponsor”), CataBoom Technologies LLC (“Administrator”), their advertising and promotions agencies, and their immediate families (spouse and parents, children and siblings and their spouses) and individuals living in the same households of such employees are ineligible. Eligibility is contingent on agreement to, and compliance with, these Official Rules and Sponsor’s decisions, which are final and binding in all matters related to the Sweepstakes. Winning a prize is contingent upon fulfilling all requirements set forth herein. Sweepstakes subject to all applicable federal, state, and local laws and regulations. This Sweepstakes is offered in the United States only and shall only be construed and evaluated according to United States law. Do not enter this Sweepstakes if you are not located in the United States.
- 2. Timing:** The Sweepstakes begins on June 12, 2023 at 12:00:01 a.m. Central Time (“CT”), and ends on June 18, 2023 at 11:58:59 p.m. CT (the “Promotion Period”). The Sweepstakes consists of seven (7) entry periods (each an “Entry Period”), each starting at 12:00:01 a.m. CT and ending at 11:58:59 p.m. CT on the same calendar day. Administrator's servers are the official time-keeping devices for this Sweepstakes.
- 3. To Enter:** Each Entry Period, visit WannaGetAwayDay.com (“Promotion Site”) to enter for a chance to win. Complete and submit the entry form including your name, valid email address, your Rapid Rewards account number, and ZIP code. You will receive one (1) entry into each Entry Period. Non-winning entries from one Entry Period shall not roll into subsequent Entry Periods, if any, *but* you can return to the site to enter each subsequent Entry Period. Limit: One (1) entry into the Sweepstakes per person per Entry Period.

All entries become property of Sponsor and will not be acknowledged or returned. Incomplete entries are not eligible. Individuals who do not follow all of the instructions, provide the required information in their entry form, and/or abide by these Official Rules or other instructions of Sponsor may be disqualified. Entries must be received during an applicable Entry Period to be eligible. Sponsor’s computer is the official timekeeping device for this Sweepstakes.

No photocopied, mechanically, or electronically reproduced entries accepted. Automated entries are prohibited, and any use of automated devices will cause disqualification. Entrants may not enter with multiple email addresses nor may entrants use any other device or artifice to enter multiple times or as multiple entrants. Any attempt by any person found to enter or in any way attempt to obtain more than the authorized number of entries will be found to be ineligible, and their entries will be disqualified all as determined by Sponsor in its sole discretion. Any eligible individual participating in this Sweepstakes shall be a “Participant.” Participation must be by the Participant. Multiple entrants are not permitted to share the same email/Rapid Rewards account. In the event of a dispute as to the identity of a Participant, the authorized account holder of the email/Rapid Rewards account used to enter the Sweepstakes will be deemed to be the Participant. “Authorized Account Holder” is defined as the natural person who is assigned an account by the organization which is responsible for assigning such accounts and is the account associated with the submitted email address. Potential winners may be required to show proof of being the authorized email/Rapid Rewards account holder. If the identity of the individual who participated in the Sweepstakes cannot be resolved to Sponsor’s satisfaction, the affected individual’s entry will be deemed ineligible.

Participants are required to provide truthful information and Sponsor will reject and delete any entry that it discovers to be false or fraudulent. Sponsor will disqualify any entry from individuals who do not meet the eligibility requirements.

ARV is as of the date of printing these Official Rules. The difference in value of prize as stated herein and value at time of prize notification, if any, will not be awarded.

Daily Instant Win Game: During each Entry Period below, upon submitting a completed entry form, Participants will be entered into a Daily Instant Win Game (“Instant Win Game”). Instant Win Game prizes are randomly time-seeded throughout each Entry Period and awarded to the first person who plays at or after the time the prize is randomly seeded. Administrator is responsible for the functionality of the Instant Win Game. Winner will be notified on the Promotion Site.

Rapid Rewards bonus points have no cash value and are void if sold, purchased, brokered, or bartered. The number of bonus points needed for a particular Southwest Airlines flight is set by Southwest Airlines and will vary depending on destination, time, day of travel, demand, point redemption rate, and other factors, and is subject to change at any time until the booking is confirmed. **Points bookings do not include taxes, fees, and other government/airport charges of at least \$5.60 per one-way flight.**

Air Travel Restrictions: Air travel is subject to Southwest Airlines terms and conditions; certain restrictions may apply. Round trip travel for two (2) on Southwest Airlines will be awarded in the form of four (4) Southwest flight e-passes. Each Southwest flight e-pass is valid for one-way travel on Southwest Airlines-operated, published, scheduled service. The Southwest flight e-pass will bear the date of issue and the date of expiration. Expiration dates will not be extended, and travel must be completed on or before the expiration date. The Southwest flight e-pass is not valid on interline or codeshare service. The Southwest flight e-pass is non-refundable and is not redeemable for cash or credit. The Southwest flight e-pass will not be replaced for any reason, including, without limitation, if lost, stolen, or fraudulently used. The Southwest flight e-pass is non-transferrable and cannot be sold to a third party. Sale, auction, or re-tendering of the Southwest flight e-pass for money or otherwise is strictly prohibited. The Southwest flight e-pass may not be used for promotional purposes unless previously approved by Southwest Airlines. Any suspected fraud, misrepresentation, misuse, abuse or violation of the Southwest flight e-pass rules and regulations may result in cancellation of the Southwest flight e-pass(es). Southwest flight e-pass holders are required to be nineteen (19) years of age or older and a legal U.S. resident. However, the recipient of a Southwest flight e-pass may arrange travel for another person if done without selling or bartering a Southwest flight e-pass. Companion Pass Restrictions: Promotional Companion Pass is valid through June 30, 2024 Promotional Companion Pass entitles the winner to designate a an individual to fly with the winner (such designated individual, the “Companion”) to fly free of carrier charges (does not include taxes and fees from \$5.60 one-way) anywhere with the winner on the same Southwest Airlines flight that is purchased (with cash or points) by the winner and booked through Southwest Airlines during the Companion Pass validity period. **Promotional Companion Pass travel is subject to taxes, fees, and other government or airport-imposed charges from \$5.60 per one-way trip.** Applicable taxes, fees, and other government or airport imposed charges can vary significantly based on your arrival and departure destination. A Companion's reservation is not considered a purchased flight, and therefore, another Companion Pass reservation cannot be booked from it.

The winner must first book and purchase his/her flight in cash or points through Southwest Airlines and then book the Companion's flight through Southwest Airlines by choosing the Rapid Rewards Companion Pass booking option on [Southwest.com](https://www.southwest.com), or if calling our toll-free reservations number at 1-800-248-4377, notifying the Customer Representative that a Rapid Rewards Companion Pass will be used. Both the winner and the Companion must be booked on the same flights and dates. If the winner's ticket is cancelled, the Companion's ticket will also be cancelled. If the winner changes his/her ticket, the winner must also change the Companion's ticket to match the winner's ticket changes or the Companion's ticket will be cancelled. If the Companion is not traveling with the winner, the Companion will be required to pay for his/her ticket. The winner and the Companion must check in together and, if asked, present the Companion Pass card at the Southwest Airlines' Ticket Counter, Skycap podium, or Departure Gate in order for the Companion to travel. Valid photo identification for both winner and the Companion is required. The winner and the Companion must board with their assigned group(s). For A-List and A-List Preferred winners who have also qualified for a Companion Pass, reserved boarding privileges will not be provided to the Companion unless the Companion is also an A-List or A-List Preferred winner.

The winner will automatically be notified of Companion Pass eligibility and provided with Companion Pass rules and instructions for designating a Companion. The winner is limited to one Companion at any time. The Companion Pass card is not transferrable. The Winner may, however, change his/her designated Companion and request issuance of a new Companion Pass card up to three (3) times each calendar year that the winner maintains Companion Pass status. Any reservation with the current Companion Pass would need to be cancelled before changing his/her designated Companion. Requests may be made by calling 1-800-435-9792. Allow 21 business days for processing and issuance of the Companion Pass card. The winner's designated Companion must be an individual. An individual may not travel as both a winner and a Companion on the same flight. Corporations and other entities cannot be designated as Companions.

The Companion Pass card is the property of Southwest Airlines and must be surrendered upon request. The Companion Pass card is not a credit card.

If an eligible winner chooses not to obtain a Companion Pass card, no alternative award will be provided.

- 5. Prize Fulfillment:** Prizes will be awarded within eight (8) weeks following the end of the Promotion Period. Winners with total prizes that exceed \$600 in value will be required to complete and sign an Affidavit of Eligibility and Liability Release and, where legal, a Publicity Release (collectively, the “Required Documentation”). The Required Documentation will be emailed, based on the potential winner's preference upon account validation. If a potential winner cannot be contacted using the information provided or fails to respond to Sponsor's attempt to notify them of selection within 72 hours; if any notification is returned as undeliverable or yields an error of undeliverable type “bounce back” email (regardless if the message is ultimately delivered to

the recipient); if Sponsor is unable to verify potential winner's eligibility; if potential winner fails to sign and return the Required Documentation within the required time period or fails to comply with these Official Rules; if any prize is returned undeliverable; if a potential winner is unable or unwilling to accept the prize as stated; or if the potential winner cannot be verified as eligible for any other reason, the potential winner is disqualified and an alternate winner will be selected by random drawing from among the eligible entries for all Entry Periods. In the event that a potential winner is disqualified for any reason, the next received and eligible entry received by Sponsor that is fully compliant with these Official Rules shall be deemed the winner, until the prize is awarded or until two (2) attempts have been made to award the prize and each attempt has failed. Sponsor, in its sole discretion, will attempt to contact up to three (2) potential winners of a prize in accordance with the above procedure, after which the prize in question may go unawarded if it remains unclaimed. Sponsor will identify each potential winner and verify the potential winner's eligibility after the end of the Sweepstakes Period. If unable to verify eligibility, Sponsor will select an alternate potential winner within a reasonable time thereafter. If applicable, winner's guest must execute a Liability Release and, where legal, Publicity Release ("Guest Documents"), which must be returned with the winner's Required Documentation prior to the issuance of travel documents or the guest portion of the prize will be forfeited. If a guest is younger than eighteen (18) years of age, guest's parent or legal guardian must sign Guest Documents on behalf of such guest and accompany such minor guest.

- 6. Conditions:** Payments of all applicable federal, state, and local taxes are solely the responsibility of the winner. Winner may be required to sign an IRS Form W-9 with the winner's full social security number or the equivalent. Failure to submit a Form W-9 upon request will result in forfeiture of the prize. Winnings of \$600 or more will be reported to the IRS in the calendar year in which the prize is awarded.

By participating in the Sweepstakes, winner agrees to have his/her name, voice, likeness, photograph, statements, opinions, biographical information and/or Sweepstakes entry used in any advertising or broadcasting material, whether relating to this Sweepstakes or otherwise, in any media, worldwide, now known or hereinafter developed, in perpetuity, without additional notice, payment, or other compensation unless prohibited by law, and, where legal, to sign a publicity release confirming such consent prior to acceptance of the prize.

Sponsor, in its sole discretion, reserves the right to disqualify any person tampering with the entry process, the operation of Sponsor's website, or otherwise in violation of the Official Rules. Sponsor further reserves the right to cancel, terminate or modify the Sweepstakes if it is not capable of completion as planned, including infection by computer virus, bugs, tampering, unauthorized intervention or technical failures of any sort. In such event, Sponsor reserves the right, but not the obligation, to award any applicable prize(s) from the entries submitted before the cancellation, suspension, or modification of the Sweepstakes. Any attempt to undermine the operation of the Sweepstakes may be a violation of criminal and civil law, and, should such attempt be made, Sponsor reserves the right to seek damages from any such person to the fullest extent permitted by law.

Sponsor reserves the right to make changes in the Official Rules, including the substitution of a prize of greater or equivalent value, which will become effective upon announcement.

Failure to comply with the Official Rules may result in Participant's disqualification solely at the discretion of the Sponsor.

The Sponsor is not responsible for typographical or other errors in the administration of the Sweepstakes or in the announcement of a prize.

In the event a prize is mailed or emailed to a winner, it will be with the prior written consent of the winner and therefore, winner assumes the risk of its loss. Sponsor is not responsible for the safe arrival of a prize. Sponsor is not responsible if potential winner does not receive his/her prize because erroneous, expired, canceled, fraudulent, or fake information was provided during the Sweepstakes. Only the prize(s) set forth in these Official Rules will be awarded. If, through printing or production error, or for any other reason whatsoever, more prizes are claimed than intended and/or set forth in these Official Rules, Sponsor reserves the right to award only the stated number of prizes from all legitimate, unawarded, eligible prize claims.

Sponsor is not liable to a winner or to any other person for failure to supply the prizes described herein (or any part thereof) by reason of such prizes (or any portion thereof) becoming unavailable or impracticable to award for reasons beyond the reasonable control of the Sponsor, or for any force majeure event, technical or equipment failure, terrorist acts, labor dispute,

pandemic, or act/omission of any kind (whether legal or illegal), transportation interruption, civil disturbance, or any other cause beyond the reasonable control of the Sponsor.

Indemnification; Limitation of Liability:** NEITHER SPONSOR, ADMINISTRATOR, NOR THEIR SUBSIDIARIES AND AFFILIATED ENTITIES IS RESPONSIBLE FOR PRINTING OR TYPOGRAPHICAL ERRORS IN ANY SWEEPSTAKES-RELATED MATERIALS OR TRANSACTIONS THAT ARE PROCESSED LATE OR INCORRECTLY OR ARE LOST DUE TO COMPUTER OR ELECTRONIC MALFUNCTION.
